## 9- Feedback of the Social Benefits Working Group

The Social Benefits WG are currently preparing detailed information pack as announced at the Executive Committee in Roda de Bara. The WG will request the information from the members over the next couple of months and will present the information Executive pack the Committee in Zagreb.

#### 10- Feedback of the Diversity Working Group

The Diversity WG are currently preparing a short survey on the implementation of the Equality, Diversity & Inclusion Charter. The WG will meet on 22<sup>nd</sup> of January to finalise and issue the survey.

#### 11-Feedback of the YUS Working Group

Laurent Jadoul (Co-ordinator of the YUS WG) gave a brief update on the current survey that the WG have issued to all staff but they only require responses from staff aged 40 or under. The completed survey must be returned by 15<sup>th</sup> February.

#### 12- Feedback of the IT Working Group

Pavlos Theotokatos (Co-ordinator of the WG) expressed his disappointment that the ECB did not agree to set up a joint IT Working Group. He did mention that, as there are ongoing issues within IT, he will keep pushing for a joint working group to be set up.

The IT WG will meet in February to explore all avenues open to them.

#### 13- Creation of the Euro Digital Working Group

The Executive Bureau have agreed to set up a Euro Digital WG with Raoul Barone as the Co-ordinator. An email will be issued shortly to invite members to join the working group.
